Background Information

About BirdLife International

BirdLife International (BLI) is the world's largest nature conservation partnership. Together we have over 115 BirdLife Partners worldwide and growing, with almost 11 million supporters, 7,000 local conservation groups and 7,400 staff.

In order to save the planet, nature and species, we use our seminal bird science, collecting and analyzing data from around the world to implement the most effective and innovative conservation measures possible. We are the official scientific source of information on birds for the IUCN Red List.

Uniquely, we have also identified and documented more than 13,000 Important Bird and Biodiversity Areas (IBAs) which are places of global significance for the conservation of birds and other biodiversity, creating practical tools for conservation and a wider integrated approach to conservation and the sustainable use of the natural environment.

Bird migration is one of the great wonders of the natural world. Our mascot, the Arctic Tern, migrates from one pole of the planet to the other between their breeding and wintering grounds – migratory birds don't choose their routes randomly, they follow Flyways, 8 bird super-highways, where they stop and can rest and refuel along the way, often in one of the IBAs mentioned above.

At BirdLife we work together with our local communities along these Flyways to protect birds and biodiversity in an integrated way for the greatest conservation outcomes

How We Work

We are a global family of over 115 national Partners covering all continents, landscapes and seascapes. With regional offices in Accra, Amman, Brussels, Cambridge, Dakar, Nairobi, Singapore, Suva, Tokyo, and Quito, we are the largest international partnership for nature conservation

We have over 13 million individual members and supporters, and unify over 100 nature conservation organisations from across the planet.

BLI is driven by our belief that local people – working for nature in their own places, but connected nationally and internationally through our global Partnership – are the key to sustaining all life on earth. Explore the World's Flyways

When travelling between their breeding and wintering grounds, birds don't choose their paths at random. They follow set routes that include suitable habitats where they can stop to rest and refuel along the way.

Many different species share broadly similar routes, which have been loosely split into four major flyways – think of

them as bird super-highways across the sky. BirdLife links together conservation organisations in countries along the length of the flyways, combining resources and coordinating action to protect birds on every step of their route.



Purpose

Reporting to the Chief Development Officer (CEO), the Head of Philanthropy and Partnerships (Asia) is responsible for the development of a fundraising strategy to support the Asia conservation priorities.

As a member of the Global Development Team, the incumbent will work closely with the Regional Director for Asia to focus initially on the Asian Development Bank Regional Flyways Initiative (RFI). This will include the development of a fundraising strategy and communications plan to support this initiative.

The role will fundraise for a wide range of initiatives including protection of conservation of bird and biodiversity areas, climate change mitigation, sustainable agriculture, and building capacity for nature conservation in Asia. They will identify major donors - foundations, individuals and corporates - from the region focusing on Singapore, China, Hong Kong, Indonesia, Vietnam and Thailand.





Key Criteria for Success

After 12 months in post, the successful candidate will have:

- Developed a good understanding of BLI, its partners and the extensive conservation initiatives around the world including BLI's position as a global leader in the conservation space.
- Identified opportunities for growth from new prospective donors in the Asia region.
- Developed a robust pipeline to ensure that the annual fundraising targets have been met.
- Fully embedded themselves within BLI, establishing themselves as a collaborative member of the Asia and Global Development Teams, and developed strong relationships with donors, board members and other key stakeholders.

Key Responsibilities

Strategy

- Develop a fundraising strategy for Asia and achieve a financial target of USD500,000 per year.
- Work collaboratively with the Board, Asia Regional Director and Global Development Team to build and nurture key donor relationships.

Philanthropy, Partnerships and Engagement

- Develop and lead an Asia fundraising portfolio with financial targets and a focus on institutional donors (multi/bilateral) and high net-worth individuals in Asia, but recognising other funders as appropriate to an internally and externally linked conservation programme and donor narrative.
- Solicit donors under the direction of the CDO with guidance from the Asia Regional Director.
- Develop funding proposals and budgets at a regional and national scale with Global Development Team, Asia Regional Office and BirdLife Partner organisations.

- Partner with the Asia Regional Director and Global Development Team in managing key donor relationships
- Work with the Asia Regional Office and Global Development and Communication Teams to develop appropriate donor engagement tools which include video, brochure, website contribution, donor reports and proposals.

Donor Idenification, Reporting and Data Management

- Conduct research and identify potential donors for the BirdLife Secretariat in Asia and Partners, and share the information with the Global Development Team.
- Maintain a record of donations and budgets in relation to fundraising initiatives led by the Asia Regional team.
- Ensure all donor activity is accurately recorded and updated in a timely manner in the database.
- Ensure donor reports are of high quality and sent in a timely fashion, and assist Partner organisations in this area, if needed.

Global Support

- Undertake specific tasks to support the wider fundraising effort for the Asia region, including fundraising events and fundraising training, when required.
- Support the Asia Regional Director and the Global Development Team in contributing to tools and training for improving donor stewardship across the wider BirdLife Organisation.



Person Specification

Experience and knowledge

- An undergraduate degree or equivalent, or a combination of relevant experience and skills.
- A proven track record in philanthropic fundraising, preferably with high-networth individuals and institutional donors, Asia-orientated Trusts, Foundations and Corporations at the 6-figure level and above.
- Demonstrable experience in preparing senior management and/or board

- members in making an ask, preparing materials and coaching them in the solicitation process.
- Experience in managing donor relations, ideally with Asia and/or Pacific links.
- Experience researching institutional funding opportunities.
- Technical fundraising expertise including problem analyses, logical frameworks and budgeting capabilities.

- Good understanding of conservation, development and political interests in Asia and Pacific countries and territories.
- Experience using CRM systems such as Raisers' Edge NXT.


Desirable
